

## **Reservations Policy and Rental Agreement** (For Group, Weekly or Monthly Reservations Only)

<b>Minimum Nights</b> Banks Lake Lodge and RV Resort requires a 3-night minimum stay for Memorial Day, July 4 <sup>th</sup> , Labor Day and all weekends during peak season, as well as a 2-night minimum stay for weekdays during peak season (for the trailer, cabins, and kitchenettes). Shorter stays will be allowed only by arrangement with the manager when making your reservations.	Customer Initials
Terms of Payment All deposits to Banks Lake Lodge & RV Resort must be by major credit card (Visa, MasterCard or American Express). To make a reservation, have your credit card handy and call us at 509-632-5596. Weekly reservations require you to make a deposit equivalent to the first nights rental rate, which includes a non-refundable \$35.00 reservation fee. Monthly and Entire Site reservations require you to make a deposit of 25% of the fee for the cabins, rooms RV sites, or entire site being reserved, which includes a non-refundable \$35.00 reservation fee. At the time of check-in we will accept only money orders, certified checks, travelers checks, or major credit cards.	Customer Initials
Damage, Cleaning and Pet Deposit Pets require a \$10.00 per day non-refundable pet fee. For weekly, monthly and entire site rentals a damage/cleaning deposit of \$250.00 is required at check-in using a major credit card. An authorization will be run on your credit card and automatically taken off your credit card after your departure, provided there is no damage or stolen items. If extra cleaning is required after you depart, it will cost a minimum of \$100.00, depending on the nature of the extra cleaning required.	Customer Initials
